

Letters Patent

Elizabeth the Second, by the Grace of God, of the United Kingdom,
Canada and Her Other Realms and Territories, Queen, Head of the
Commonwealth, Defender of the Faith.

To all to whom these presents shall come – Greeting.

Minister of Community, Sport and Cultural Development
and Minister Responsible for TransLink

Whereas the Greater Vancouver Regional District, a regional district incorporated as the Regional District of Fraser - Burrard by Letters Patent issued on June 29, 1967 (Order in Council 2130/1967), and

Whereas a request has been received by the Minister of Community, Sport and Cultural Development and Minister Responsible for TransLink from the board of the Greater Vancouver Regional District requesting that the name of the regional district be changed;

Now know ye that We do by these presents proclaim and order as follows:

- 1 *The Greater Vancouver Regional District is renamed and shall be called and known by the name of "Metro Vancouver Regional District".*
- 2 *On or after the date these Letters Patent are issued, a reference to the Greater Vancouver Regional District in any commercial paper, lease, permit or other contract, instrument or document is deemed to be a reference to the Metro Vancouver Regional District.*

3 All bylaws, permits, resolutions, licences or other actions passed, made, issued or otherwise approved by the Greater Vancouver Regional District shall remain in full force and effect as if passed, made, issued or otherwise approved by the Metro Vancouver Regional District.

In testimony whereof, We have caused these Our Letters to be made Patent and the Great Seal of Our Province of British Columbia to be hereunto affixed.

Witness, The Honourable Judith Guichon, Lieutenant Governor of Our Province of British Columbia, in Our City of Victoria, in Our Province, this thirtieth day of January, two thousand seventeen and in the sixty fifth year of Our Reign.
