The Lieutenant-Governor in Council:

The undersigned has the honour to report:

THAT under the provisions of Section 30 of the "Forest Act" being Chapter 102 of the Revised Statutes of British Columbia, 1936, and amending Acts, the Moresby Forest Reserve was established by Order-in-Council 79, January 23, 1940, to cover an area shown outlined in red on a map of record in the Department of Lands under Number 26, Locker 30.

THAT Anthony Island, contained within the Moresby Forest Reserve at latitude 52° 06' north and longitude 131° 12' west, is the site of an ancient abandoned Haida Indian Village and is of outstanding historic interest as well as considerable archaeological importance.

AND THAT the 345 acres comprising Anthony Island are rocky, support mainly scrub timber and have no apparent resource values which would conflict with preservation of the historic and archaeological values as park.

AND TO RECOMMEND THAT under Subsection 3 Section 30 of the "Forest Act", Chapter 128, Revised Statutes of British Columbia, 1948, the Moresby Forest Reserve be cancelled insofar as it applies to Anthony Island.

AND THAT under authority of Section 128 of the said "Forest Act", Anthony Island be constituted a Provincial Park.

AND THAT under Section 129 of the "Forest Act", Anthony Island Park be of Class "A".


