



Brooks Peninsula Recreation Area, established by Order in Council 2210/86, is cancelled,
Elk Lakes Recreation Area, established by Order in Council 1716/86, is cancelled,
Fry Creek Canyon Recreation Area, established by Order in Council 3856/74, is cancelled,
Kokanec Glacier Recreation Area, established by Order in Council 394/89, is cancelled,
Nisga'a Memorial Lava Bed Recreation Area, established by Order in Council 666/92, is cancelled,

Order in Council 611/86 is amended by deleting Schedule 8 (Bugaboo Alpine Recreation Area).
Order in Council 396/89 is amended by deleting the Wells Gray Recreation Area - Flourmills Site Schedule.
