Whereas the Corporation of the District of Maple Ridge
was re-incorporated by Letters Patent issued on
December 7, 1887 (Order in Council 289/1887), and

Whereas a request has been received by the Minister of Community, Sport and Cultural Development from the Council of the Corporation of the District of Maple Ridge requesting a change of municipal classification from a district municipality to a city;

Whereas the Council of the Corporation of the District of Maple Ridge has obtained elector approval for the proposed change in classification;

Whereas the Lieutenant Governor in Council considers it to be in the public interest to change the municipal classification as requested;

Now know ye that We do by these presents proclaim and order as follows:

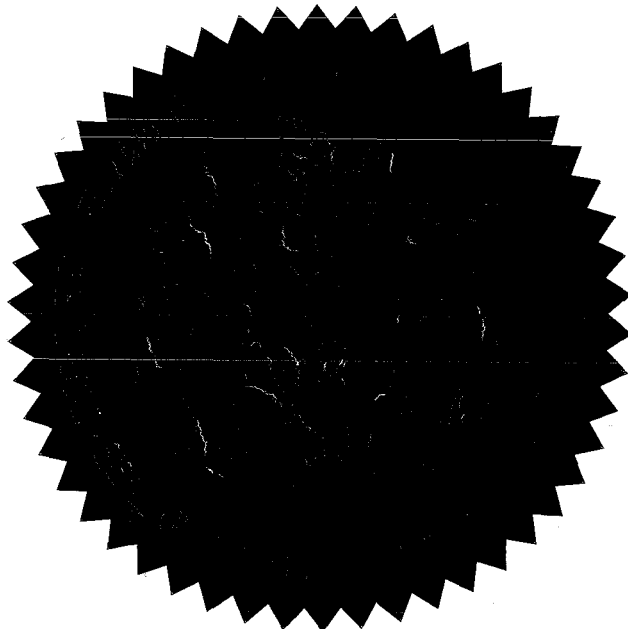
- The Corporation of the District of Maple Ridge is reclassified as a city and the municipality shall be called and known by the name of the "City of Maple Ridge".*

- 2 *On or after September 12, 2014, a reference to the Corporation of the District of Maple Ridge or to the District of Maple Ridge in any commercial paper, lease, license, permit or other contract, instrument or document is deemed to be a reference to the City of Maple Ridge.*
- 3 *All bylaws, permits, resolutions, licences or other actions passed, made, issued or otherwise approved by the Corporation of the District of Maple Ridge shall remain in full force and effect as if passed, made, issued or otherwise approved by the City of Maple Ridge.*

In testimony whereof, We have caused these Our Letters to be made Patent and the Great Seal of Our Province of British Columbia to be hereunto affixed.
