
Order in Council No. 605 , Approved and Ordered December 20, 2017

On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

- (a) Letters Patent under the Great Seal be issued appointing members of the Bar of the Province of British Columbia as set out in the attached Schedule as Provincial officers under the names of Her Majesty's Counsel learned in the law for the Province of British Columbia, and
- (b) subject to section 6 of the *Queen's Counsel Act*, the members listed in the attached Schedule shall have precedence in the Courts of the Province of British Columbia,
 - (i) after all other Provincial officers learned in the law for the Province appointed prior to the date of this order, and
 - (ii) as between themselves, in the order in which their names appear in the attached Schedule.
