## SCHEDULE

The bylaws made by the College of Dietitians of British Columbia under the authority of the *Health Professions Act* are amended as follows:

1. **Subsection 42(1)(b)** is amended by adding the word "must" after the word "applicant".
2. **Subsection 42(1)(b)(i)** is amended by deleting the words "has submitted an application" and adding the word "apply" in front of the word "for".
3. **Subsection 42(1)(b)(ii)** is repealed and replaced by "consent to a criminal record check in the form required by the Criminal Records Review Act;"
4. **Subsection 42(1)(b)(iii)** is amended by adding the words "hold registration in another jurisdiction in Canada or the United States of America as the equivalent of a full registrant, which" in front of the word "is".
5. **Subsection 42(1)(b)(iv)** is amended by deleting the words "has provided" and adding the word "provide" in front of the word "evidence".
6. **Subsection 42(1)(b)(v)** is amended by adding the words "provide evidence that they are" and deleting the word "is" in front of the word "a", and deleting the word "Canadian" and adding the word "Canada" after the word "the", adding the words "of America" in front of the word "States", and deleting the word "and" and adding the word "or" after the word "forces".
7. **Subsection 42(1)(b)(vi)** is amended by deleting the words "has provided" and adding the word "provide" in front of the word "evidence" and deleting the word "membership" and adding the words "good character" after the word "applicant's".
8. **Section 42(4)** is amended by deleting the word "without" and adding the word "by" after the word "activities", adding the word "emergency" after the word "the", and deleting the words "and paying the fees required in section 45" and adding the words "restricted activities" after the word "application".
9. **Schedule D, Fees** is repealed and replaced with the following:
