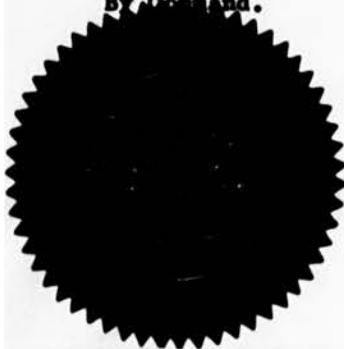
AND THAT nothing contained in these presents shall affect any object, power, obligation, or duty of the regional district:
